## **ORDER DIRECTING STAFF TO FILE RECOMMENDATION AND SETTING DEADLINE FOR RESPONSES**

On December 15, 2025, Union Electric Company d/b/a Ameren Missouri filed an application requesting authority to issue and sell additional long-term indebtedness. In addition, Ameren Missouri requested waiver of the Commission's 60-day notice requirement<sup>1</sup> and expedited treatment.<sup>2</sup>

The Commission will direct its Staff to file an expedited recommendation regarding Ameren Missouri's application. The Commission will also set a deadline for responses to Staff's recommendation.

## THE COMMISSION ORDERS THAT:

1. No later than January 9, 2026, Staff shall file a recommendation regarding Ameren Missouri's application.
2. Responses to Staff's recommendation shall be filed no later than January 14, 2026.
3. This order shall be effective when issued.
