ORDER CANCELLING REGISTRATION

Issue Date: December 23, 2025

Effective Date: January 2, 2026

On December 11, 2025, DentalTek, LLC filed a letter notifying the Commission that it wished to cancel its registration to provide Interconnected Voice over Internet Protocol (IVoIP) telecommunication services in Missouri. The letter stated that DentalTek has closed and no longer has customers or telecommunication operations in the state of Missouri as of December 1, 2025. DentalTek was granted an IVoIP registration in Case No. DA-2022-0101.

Commission Rule 20 CSR 4240-28.011(3) permits a company to cancel a registration by filing a letter signed by a company official that identifies when and which certificate to cancel. Based on the request of DentalTek, the Commission finds that registration granted to it to provide IVoIP telecommunications services in Missouri shall be cancelled.

THE COMMISSION ORDERS THAT:

1. The registration to provide IVoIP telecommunications services, granted to DentalTek, LLC in Case No. DA-2022-0101, is cancelled.
2. This order shall become effective on January 2, 2026.
3. This case shall be closed on January 3, 2026.
