NOTICE THAT PLEADINGS WERE REJECTED

Issue Date: December 23, 2025

On December 18, 2025, Complainant, Brett Felber, submitted documents for filing in the Commission's Electronic Information Filing System (EFIS). Several of these pleadings were rejected.

The documents titled *Federal Rico Complaint, Application for Rehearing, Notice of Appeal, Memorandum of Alleged Facts and Request for Investigation, and Appellate Brief of Appellant* were rejected.

The *Federal Rico Complaint, Notice of Appeal, and Appellate Brief of Appellate* are inappropriately filed with the Commission. The Commission is not a federal court and it has been explained to Felber that the Commission does not preside over appeals of its orders. Felber must file an action with the appropriate court.

Felber's *Application for Rehearing* was rejected because it is untimely, the Commission has already denied rehearing, and Felber has already filed a previous application for rehearing out of time.

Memorandum of Alleged Facts and Request for Investigation was rejected because this complaint was dismissed and the Staff of the Commission has already investigated this complaint and filed its report.

Felber's *Motion to Declare Order Void and to Vacate* will be filed in his complaint.
