## MOTION FOR EXPEDITED TREATMENT

COMES NOW Summit Natural Gas of Missouri, Inc. (SNGMO or Company), and, in accordance with Missouri Public Service Commission (Commission) Rules 4 CSR 240-2.080(14) and 4 CSR 240-2.065(2), moves the Commission for expedited treatment

of SNGMO's tariff sheets filed on November 14, 2014:

1. On October 29, 2014, the Commission issued its Report and Order

(effective November 28, 2014). In that Order, among other things, the Commission

ordered SNGMO to file tariff sheets consistent with the Report and Order.

2. Concurrently, with the filing of this Motion, SNGMO has filed tariff sheets

in order to comply with the Commission Order (copies of which are provided as

**Appendix A**). These tariff sheets carry a proposed effective date of December 14,

2014, and were assigned tracking number YG-2015-0207.

3. SNGMO seeks the Commission's order allowing the proposed tariff sheets to go into effect on December 1, 2014.

4. SNGMO filed the rate case requests that form the basis for this case on January 2, 2014. The Commission's Report and Order has authorized a rate increase for SNGMO. Thus, the tariff sheets are being filed in compliance with Commission order. The Commission and the public have been aware of SNGMO's request for a rate increase for approximately ten and one-half months. Lastly, a December 1, 2014

effective date will be more conducive to changes in SNGMO's billing system than a midmonth change and less likely to result in billing issues.

5. Granting this Motion will avoid further delay in regard to the rate relief which the Commission has found to be just and reasonable. As such, Commission action as requested will be consistent with the public interest as established by the General Assembly and Commission order.

6. The subject tariff sheets and this Motion have been filed as soon as possible after the issuance of the Commission's Report and Order and discussion with the Staff of the Commission concerning review of the tariff sheets and the proposed rates.

WHEREFORE, for the foregoing reasons, SNGMO respectfully requests the Commission to grant SNGMO's Motion for Expedited Treatment and approve SNGMO's proposed tariff sheets (Tracking No. YG-2015-0207) to be effective on December 1, 2014.
