ORDER GRANTING APPLICATION TO INTERVENE

Union Electric Company d/b/a Ameren Missouri filed an application for a certificate of convenience and necessity authorizing it to construct, install, own, operate, control, manage, and maintain approximately 28 miles of 345 kV transmission line and associated facilities in Callaway County and Montgomery County. On December 12, 2025, the Missouri Farm Bureau Federation filed an application to intervene. Ten days have elapsed and no party has objected to the application to intervene.¹ The application satisfies the requirements of Commission Rule 20 CSR 4240-2.075 and intervention will be granted.

THE COMMISSION ORDERS THAT:

1. The Missouri Farm Bureau Federation's application to intervene is granted.

¹ Commission rule 20 CSR 4240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission.

2. This order shall be effective when issued.
