ORDER EXTENDING TIME FOR RECOMMENDATION

On November 5, 2025, Spire Missouri Inc. (Spire) filed the above-referenced application.

The Commission directed its Staff to file a recommendation, or an alternative pleading, no later than December 22, 2025. On December 19, 2025, Staff filed a *Status Report and Motion for Extension of Time to File Staff Recommendation* stating that it has made data requests to Spire and, based on the responses received, requests additional time to complete its investigation and file its recommendation.

The Commission set a deadline for responses to Staff’s motion, and no responses were filed. The Commission will grant the motion and extend the time for Staff to file its recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation on Spire’s application, or a status report, no later than March 23, 2026.

2. This order is effective when issued.
