## ORDER EXTENDING TIME FOR RECOMMENDATION

Issue Date: December 30, 2025

Effective Date: December 30, 2025

On October 24, 2025, The Empire District Electric Company d/b/a Liberty filed the above-referenced application, proposing to construct a 250 MW combustion turbine generator.

The Commission directed its Staff to file a recommendation, or an alternative pleading, no later than December 15, 2025. On that date, Staff filed a *Status Report* stating that it has made data requests to Liberty, received some responses, and expects follow-up inquiries and data requests will be necessary. Therefore, Staff anticipates that it can provide a recommendation on Liberty's application no later than March 16, 2026.

No parties have responded to the *Status Report*. The Commission will direct Staff to file its recommendation or a status report by Staff's anticipated date.

### THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation on Liberty's application, or a status report, no later than March 16, 2026.
2. This order is effective when issued.
