## ORDER DIRECTING FILING

On February 27, 2025, the Commission issued its *Order Opening an Investigation* directing the Commission Staff to conduct an investigation regarding the Liberty Utility companies operating in the state of Missouri with regard to Liberty Utilities' billing and customer service issues. The Commission ordered to file status reports every three months, beginning on April 30, 2025, informing the Commission of the status of its investigation and stating when it expects to file its final investigation report.

On September 18, 2025, Staff filed a status report indicating that it has been meeting with the Liberty Utility companies and conducting discovery. Staff stated it expects to file its final investigation report by December 31, 2025. Therefore, the Commission will set that date for Staff to file its investigation report or file a further status report.

**THE COMMISSION ORDERS THAT:**

1. No later than December 31, 2025, Staff shall file its investigation report or a status report stating when it expects to file its final investigation report.
2. This order shall be effective when issued.

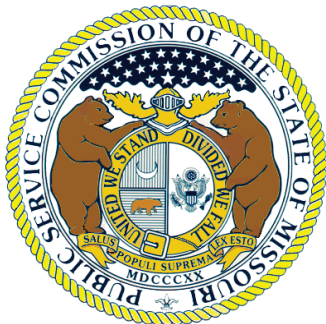
