**MOTION FOR ORDER RECOGNIZING
EXTENSION OF TARIFF EFFECTIVE DATE**

COME NOW, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West” or “Company”), Staff (“Staff”) for the Missouri Public Service Commission (“Commission”), and the Office of the Public Counsel (“OPC”) (collectively, the “Parties”) and state:

1. On December 19, 2025, the Company filed tariff revision JE-2026-0077 (“Tariffs”) bearing an issue date of December 19, 2025, and an effective date of January 1, 2026.
2. On December 23, 2025, the Company filed a *Motion for Expedited Treatment*, requesting that the Commission issue an order permitting the Tariffs to go into effect on January 1, 2026.
3. Also on December 23, 2025, the Commission issued its *Order Shortening Time for Responses to Stipulation and Agreement and Request for Variance*, setting a response date to the *Motion for Expedited Treatment* of December 30, 2025.
4. Following discussions amongst the Parties on the morning of December 30, 2025, which culminated in an agreement that the Company should extend the effective date of the Tariffs to January 18, 2025, to allow further exchange of information and discussions amongst the Parties toward resolving Staff’s and OPC’s questions, the Company is extending the effective date of the Tariffs to January 18, 2026, which moots the Company’s *Motion for Expedited Treatment*.

WHEREFORE, the Parties respectfully request the Commission to issue an order that recognizes Evergy Missouri West's extension of the effective date of tariff revision JE-2026-0077 from January 1, 2026, to January 18, 2026, in furtherance of resolving Staff's and OPC's questions, and which relieves the Parties in this case from responding to Evergy Missouri West's *Motion for Expedited Treatment* as moot.
