ORDER FURTHER SUSPENDING TARIFF SHEET AND SETTING PROCEDURAL CONFERENCE

Issue Date: December 30, 2025

Effective Date: December 30, 2025

On November 12, 2025,¹ Union Electric Company d/b/a Ameren Missouri filed a tariff sheet to establish rates for Phase 3 of its Renewable Solutions Program (RSP). The tariff sheet bears an effective date of December 12, and was assigned Tracking No. JE-2026-0068. At the direction of the Commission, on November 24, the Staff of the Commission (Staff) filed its *Report and Recommendation* on the tariff sheet, recommending that the Commission approve the rate schedule set out in the tariff sheet but suspend the tariff sheet itself.

On December 2, Ameren Missouri extended the effective date of the tariff sheet to December 19. On December 17, Ameren Missouri extended the effective date of the tariff sheet to December 24.

On December 19, Staff filed its *Preliminary Report / Motion to Suspend Tariff / Motion for Expedited Ruling* in which it disagreed with Ameren Missouri as to the nature and effect of the tariff sheet and requested the tariff sheet be suspended.

Section 393.150, RSMo, authorizes the Commission to suspend the effective date

of proposed tariff sheets for up to 120 days. On December 23, the Commission suspended the tariff sheet to December 31.

On December 29, Staff filed its *Report and Recommendation / Motion to Suspend Tariff / Motion for Expedited Treatment*. In it, Staff argues that the issues raised in the pleadings filed since Ameren Missouri's November 12th tariff filing cannot be resolved before the Commission's suspension of the tariff expires and the tariff goes into effect by operation of law. The Commission agrees and will grant the motion. In addition, the Commission will schedule a procedural conference.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri's proposed tariff sheet, filed on November 12, 2025, assigned Tracking No. JE-2026-0068, and described as follows:

MO.P.S.C. Schedule No. 6
Original Sheet No. 83.8

is further suspended, with a new effective date of January 24, 2026.

2. The parties shall appear by Webex video or phone at a procedural conference to be held on Thursday, January 8, 2026, at 9:00 a.m. The parties will be e-mailed information on how to join the conference.

3. This order shall be effective when issued.
