## ORDER DIRECTING STAFF COMPLIANCE RECOMMENDATION

On January 23, 2025, the Commission issued its order approving a stipulation and agreement resolving this general rate case.

On December 31, 2025, Liberty Utilities (Missouri Water) LLC d/b/a Liberty filed proposed tariff revisions, Tracking Nos. JW-2026-0079 and JS-2026-0080, which both bear an effective date of March 1, 2026, to comply with the Commission’s order. Those tariff sheets contain revised maps and legal descriptions. The Commission will direct its Staff to file a recommendation about whether the tariff revisions comply with the Commission’s order. The Commission will also set a time for filing other tariff comments.

### THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation about Liberty’s compliance tariff revisions, Tracking Nos. JW-2026-0079 and JS-2026-0080, no later than January 27, 2026.
  
2. Any other comments about Liberty’s compliance tariff sheets shall be filed no later than January 27, 2026.

3. This order is effective when issued.
