**RESPONSE TO COMMISSION ORDER OF DECEMBER 23, 2025**

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and as its response to the Missouri Public Service Commission's ("Commission") December 23, 2025 *Order Giving Notice of Case Filing, an Ameren Response, and Setting an Intervention Date* ("Order"), states as follows:

1. On December 23, 2025, the City of Fulton, Hannibal Board of Public Works, Kirkwood Electric, the City of Marcelline, and the City of New Madrid (collectively, "Missouri Public Power") filed a *Verified Complaint and Motion for Expedited Treatment Complaint* ("Complaint").

2. Also on December 23, 2025, the Commission issued its Order, a portion of which required Ameren Missouri to respond no later than January 5, 2026, to two issues. Those are Missouri Public Power's request for an order "prohibiting Ameren Missouri from taking any retaliatory measures, including but not limited to termination of service or of any current or pending agreement or ongoing negotiating with Missouri Public Power" and "requiring Ameren to preserve all evidence related to this matter."

3. Ameren Missouri has no objection to either request being granted.

**WHEREFORE**, the Company respectfully requests that the Commission accept this response in fulfillment of its December 23, 2025, Order.
