ORDER SETTING TIME FOR RESPONSES

On March 18, 2020, the Commission approved the *Second Non-Unanimous Stipulation and Agreement* (the “agreement”). An amendment to the agreement was approved by the Commission on May 21, 2020. On March 24, 2021, Union Electric Company d/b/a Ameren Missouri and the Office of the Public Counsel filed a *Joint Motion to Further Modify Requirements of Second Stipulation and Agreement*.

The agreement, which was not opposed, provided for certain payments by Ameren Missouri to consumer action agencies to be used for “low-income weatherization or for assistance to low-income customers for such customers’ participation in Ameren Missouri’s energy efficiency programs.”¹ Due to the effects of the COVID-19 pandemic, on May 4, 2020, Ameren Missouri and Public Counsel filed a joint motion to amend the agreement. At that time, Ameren Missouri and Public Counsel agreed that \$3.5 million of the funds donated by Ameren Missouri, originally intended to be applied toward low-income weatherization projects, would be better used providing low-income energy assistance to Ameren Missouri’s electric customers who need assistance paying their electric bills.

On May 4, 2020, Ameren Missouri and Public Counsel filed a second motion to amend the agreement. Because of the ongoing hardships caused by the continuing COVID-19 pandemic, Ameren Missouri and Public Counsel have requested a further amendment of the agreement. This amendment would redirect the remaining \$3.5 million of weatherization funds to low-income energy assistance programs and their administration.

The Commission will set a time for the other parties to respond to the joint motion.

THE COMMISSION ORDERS THAT:

1. Any response to the *Joint Motion to Further Modify Requirements of Second Stipulation and Agreement* shall be filed no later than April 5, 2021.
2. This order is effective when issued.
