On March 24, 2021,¹ the Commission issued its Order Approving Stipulation and Rejecting Production Adjustment Cost Clause (PACC) Tariff (Order). The rejected tariff had been filed on February 1, and bore an effective date of April 1. The Commission's order granted Vicinity Energy Kansas City, Inc.'s (Vicinity) Motion for Expedited Treatment and ordered Vicinity to file tariff sheets in conformity with the approved stipulation with an effective date of April 1. It set March 25 as a deadline for the tariff sheets and March 26 as the deadline for any objections thereto. On March 24, Vicinity filed Tariff Revision (YH-2021-0174). The Commission will order the Commission Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission Staff shall file a recommendation on Vicinity's Tariff Revision, tracking number YH-2021-0174 no later than March 29, 2021.
2. This order shall be effective when issued.
