**ORDER DENYING
APPLICATION FOR REHEARING**

On December 2, 2025, the Commission issued its Order granting Spire's Motion for Summary Determination dismissing the complaint. That order became effective on January 2, 2026. The Complainant filed a timely application for rehearing titled a Request for Rehearing on December 13, 2025. On December 19, 2025, Spire Missouri Inc., (Spire) filed a Response asking the Commission to deny the Complainant's request.

Section 386.500.1, RSMo 2016, states that the Commission shall grant an application for rehearing if “in its judgment sufficient reason therefor be made to appear.” In the judgment of the Commission, the application for rehearing does not demonstrate sufficient reason to rehear the matter.

The Commission will deny the application for rehearing.

THE COMMISSION ORDERS THAT:

1. Complainant's application for rehearing is denied.
2. This order shall be effective when issued.
