ORDER GRANTING MOTION FOR EXTENSION

On December 15, 2025, Union Electric Company d/b/a Ameren Missouri (Ameren) filed an application requesting authority to issue and sell additional long-term indebtedness. In addition, Ameren Missouri requested waiver of the Commission's 60-day notice requirement¹ and expedited treatment.² On December 19, 2025, the Commission issued an Order setting a January 9, 2026 deadline for Staff to file a recommendation regarding Ameren's application. On January 2, 2026, Staff filed a *Motion for Extension* to file a recommendation on January 16, 2026.

The Commission will grant Staff's *Motion* and direct its Staff to file a recommendation regarding Ameren Missouri's application. The Commission will set a date for the filing of responses to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. No later than January 16, 2026, Staff shall file a recommendation regarding Ameren Missouri's application.
2. Responses to Staff's recommendation shall be filed no later than January 21, 2026.
