## ORDER SETTING WEBEX MOTION HEARING

On December 9, 2025, the Office of the Public Counsel (Public Counsel) filed a pleading opposing setting a procedural schedule. Public Counsel asserts that the only factor that matters in interpreting the Market Price Protection Mechanism is what the Commission intended when it approved it. The Commission is treating Public Counsel's pleading as a motion in opposition to an evidentiary hearing.

The Commission directed the parties to submit available dates for a motion hearing to address Public Counsel's argument. Based upon those submitted dates the Commission will set a Webex motion hearing.

1. The parties shall appear at a WebEx motion hearing on January 20, 2026, at 1:30 p.m. The WebEx meeting information will be emailed to the parties prior to the hearing.
