ORDER DIRECTING FILING

On February 24, 2021,¹ the Commission issued its Order Granting Certificate of Convenience and Necessity to Missouri-American Water Company (MAWC) for Certificates of Convenience and Necessity authorizing it to Install, Own, Acquire, Construct, Operate, Control, Manage, and Maintain Sewer Systems in and around the City of Trimble, Missouri (Order). The order contemplated MAWC's acquisition of assets in Trimble, Missouri, and in a residential development called Centennial Acres. The order required MAWC to submit newly created and/or revised tariff sheets, to become effective before closing on the assets. On March 24, MAWC filed Revised Tariff Sheets, tracking number JS-2021-0173, with an effective date of April 23, and a Motion for Expedited Treatment (Motion).

The Motion for Expedited Treatment states that both the City of Trimble and Centennial Acres are prepared to close on April 9. It states that MAWC, accordingly, seeks the Commission's order allowing the proposed tariff sheets to go into effect on less than thirty days' notice, to be effective April 9. The Commission will order the Commission

Staff to file a recommendation on the proposed tariff sheets and set a deadline for responses or objections.

THE COMMISSION ORDERS THAT:

1. The Commission Staff shall file its recommendation on the tariff sheets with the tracking number JS-2021-0173 no later than March 29, 2021.
2. Any party wishing to object or respond to the tariffs sheets shall do so by filing a pleading no later than March 29, 2021.
3. This order shall be effective when issued.
