ORDER ESTABLISHING TIME TO RESPOND

On March 12, 2021,² Confluence Rivers Utility Operating Company, Inc. (Confluence) filed New Tariffs (YW-2021-0165 and YS-2021-0166) responsive to the Commission's Order of January 13, Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity (Order). These tariffs bear an effective date of April 11. The order required Confluence to submit an adoption notice before closing on the assets to adopt the existing Terre Du Lac tariffs; and to adopt Terre Du Lac's tariffs, adopting existing water rates for the unregulated systems in P.S.C. MO No. 1, and adopt the existing sewer rates in P.S.C. MO No. 3. On March 12, the Commission issued its order requiring the Commission's Staff to file a recommendation on the proposed tariffs. Staff did so on March 24, and recommended approval of the tariff sheets. The Commission will set a deadline for responses or objections.

THE COMMISSION ORDERS THAT:

1. Any party who wishes to file objections or responses to tariffs YW-2021-0165 or YS-2021-0166 or Staff's recommendation concerning those tariffs shall file a pleading no later than March 29, 2021.
