On March 29, 2021, Sprint Communications Company L.P. filed a letter requesting the Commission cancel its authority to provide local exchange and interexchange services in the State of Missouri. Sprint Communications also seeks to withdraw associated tariff sheets.

The Commission will direct the Staff of the Commission to file a recommendation regarding Sprint Communications' request. The Commission will instruct Staff to identify all current tariffs, if any, associated with the certificates issued to Sprint Communications for local exchange and interexchange telecommunications.
