## ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: March 30, 2021

Effective Date: April 11, 2021

On January 13, 2021,<sup>2</sup> the Commission issued its Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity (Order). The Order required Confluence Rivers Utility Operating Company, Inc., (Confluence) to adopt the tariffs of Terre Du Lac Utilities Corporation (Terre Du Lac) and to submit an adoption notice before closing on the assets to adopt the existing Terre Du Lac tariffs.

On March 12, Confluence filed new tariffs, tracking numbers YW-2021-0165 and YS-2021-0166, to adopt the existing water and sewer tariffs of Terre Du Lac pursuant to the Order; and an additional tariff sheet for both water and sewer tariffs to address a previous error in the Terre Du Lac service area description. Each tariff sheet submitted bears an issue date of March 12, and an effective date of April 11. On March 12, the Commission issued its Order directing the Commission's Staff (Staff) to file its recommendation on the proposed tariffs no later than March 25. Staff did so on March 24, and on March 26, the Commission issued its Order Establishing Time to

Respond, setting March 29 as the deadline for objections or responses to the tariffs or Staff's recommendation. No objections or responses have been received.


Staff's recommendation states that Staff reviewed the tariff adoptions and determined that they are in compliance with the Commission's January 13 order. Staff recommends the Commission approve the tariff sheets to adopt Terre Du Lac's currently effective water tariff (YW-2021-0165) and sewer tariff (YS-2021-0166), bearing effective dates of April 11. Upon reviewing the pleadings, the Commission finds Confluence's tariff sheets comply with the Commission's January 13 Order and will approve them. To accommodate the tariffs' effective dates, the Commission will approve the tariffs to become effective on April 11, 2021, and will make this order effective on the same date.

**THE COMMISSION ORDERS THAT:**

1. Confluence's tariff sheets adopting the existing water and sewer tariffs of Terre du Lac, YW-2021-0165 and YS-2021-0166, are approved, to become effective on April 11, 2021.
2. This order shall become effective on April 11, 2021.
