## ORDER CANCELING REGISTRATION

Issue Date: January 15, 2026

Effective Date: January 25, 2026

On December 23, 2025, Reduce Rate Long Distance, LLC filed a letter notifying the Commission that it no longer wished to retain its certificate of authority to provide intrastate interexchange telecommunications services in Missouri. The letter stated that Reduce Rate Long Distance, LLC is no longer providing telecommunication services or doing business in the state and has no Missouri customers. Reduce Rate Long Distance, LLC was granted its certificate of authority in Case No. TA-2002-55. Reduce Rate Long Distance, LLC has a currently effective tariff, assigned Tracking No. JX-2003-0830, which it also requested to cancel.

Commission Rule 20 CSR 4240-28.011(3) permits a company to cancel a certificate of service authority by filing a letter signed by a company official that identifies when and which certificate and any applicable tariffs to cancel. Based on the request of Reduce Rate Long Distance, LLC, the Commission finds that certificate of authority granted to it to provide intrastate interexchange telecommunications services in Missouri shall be canceled as well as its related tariff.

**THE COMMISSION ORDERS THAT:**

1. The certificate of authority to provide intrastate interexchange telecommunications services, granted to Reduce Rate Long Distance, LLC in Case No. TA-2002-55, is canceled.
2. Reduce Rate Long Distance, LLC's tariff, assigned Tracking No. JX-2003-0830, is canceled.
3. This order shall become effective on January 25, 2026.
4. This case shall be closed on January 26, 2026.
