On January 15, 2026, Union Electric Company d/b/a Ameren Missouri filed the above-referenced application. Ameren Missouri wishes to construct a 161 kV switching station and associated facilities, known as the Vanduser Switching Station, in Stoddard County, Missouri.

The Commission will give notice of the application, and it will further allow an opportunity for interested parties to apply for intervention.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide notice of this order to the county commission for Stoddard County, Missouri.

3. Applications to intervene shall be filed no later than January 30, 2026.
