## ORDER GRANTING FURTHER EXTENSION OF TIME

On April 18, 2024, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding the acquisition of the unregulated sewer assets of Barbara E. Rampone located in and around the Timber Ridge subdivision in Johnson County, MO (Timber Ridge). Actions in the case were suspended on request of the parties. On November 7, 2025, Confluence Rivers filed to substitute a portion of its application.

The Commission directed a recommendation from its Staff (Staff) no later than January 15, 2026.

Staff timely filed a request for a one week extension of time. Staff stated it is still working on completing its investigation and recommendation.

The Commission finds the request reasonable and will grant the extension.

**THE COMMISSION ORDERS THAT:**

1. Staff's request for an extension of time is granted. Staff shall submit its recommendation no later than January 22, 2026.
2. This order shall be effective when issued.
