ORDER RECOGNIZING NAME CHANGE

Issue Date: January 20, 2026

Effective Date: January 30, 2026

On January 7, 2026, the Commission received a request from Consolidated Communications Enterprise Services, LLC d/b/a Consolidated Communications to recognize its name change to Fidium Enterprise Services, LLC d/b/a Consolidated Communications.¹ The company also requested the Commission approve the submitted adoption notices and revised tariff title sheets, assigned Tracking Nos. JC-2026-0088 and JC-2026-0089. The submitted adoption notices and revised tariff title sheets all have an effective date of February 6, 2026.

The Commission has reviewed the filings and 20 CSR 4240-28.011(2) and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name change of Consolidated

The Commission finds it reasonable for this order to become effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Consolidated Communications Enterprise Services, LLC d/b/a Consolidated Communications to Fidium Enterprise Services, LLC d/b/a Consolidated Communications.
