ORDER GRANTING VARIANCE

On January 13, 2026, the Staff of the Commission filed a Request for Variance. Staff asks the Commission to extend Staff's deadline to respond to a Notice of Adding New SPP Charge Types from January 20, 2026 to January 30, 2026.¹ Staff requested extra time to allow for review of data request responses which are not due until January 16, 2026.

The Commission allowed parties until January 16, 2026, to state objections. No objections were received.

Commission Rule 20 CSR 4240-2.205 allows the Commission to grant a variance from any Commission rule upon a finding of good cause. The Commission finds that Staff has stated good cause for the variance. Thus, the Commission will grant the variance.

THE COMMISSION ORDERS THAT:

1. Commission Rule 20 CSR 4240-20.090(8)(D)1.C.(I) is waived.
2. Responses to the Notice of Adding New SPP Charge Types shall be filed no later than January 30, 2026.

¹ Because Evergy Missouri West filed its Notice of Adding New SPP Charge Types on December 18, 2025, Staff's deadline to respond pursuant to 20 CSR 4240-20.090(8)(D)1.C.(I) would be January 20, 2026.
