The Commission is correcting its *Order Approving Demand Side Investment Mechanism Rider Rate Adjustment Tariffs*, issued January 15, 2026, nunc pro tunc under Commission Rule 20 CSR 4240-2.160(4), to correct the second sentence of the second paragraph of the second page of the order, referencing the effect of the proposed tariff on the residential Demand Side Investment Mechanism (DSIM) Rider rate. The sentence is corrected to read as follows:

For Evergy Missouri Metro, the proposed tariff sheet decreases the current residential DSIM Rider rate from \$0.00402 per kWh to \$0.00296 per kWh for residential customers.

1. The Commission's *Order Approving Demand Side Investment Mechanism Rider Rate Adjustment Tariffs*, issued January 15, 2026, is corrected nunc pro tunc, as set forth in the body of this order
