On January 8, 2026, Michael K. Lavanga and Joseph R. Briscar filed a motion for leave to appear *pro hac vice* as attorneys for Nucor Steel Sedalia, LLC.

The Commission has reviewed the motion and finds it complies with the requirements of Commission Rule 20 CSR 4240-2.040(3)(C) and Missouri Supreme Court Rules 6.01 and 9.03.
