On January 15, 2026, the Commission received the above-referenced application requesting renewed authority as an Information and Referral Provider. On January 20, 2026, pursuant to a *Notice of Deficiency* issued by the Commission, the application was re-submitted with accompanying exhibits.

The Commission will issue notice of the application to the general public. The Commission will also set a deadline for intervention requests and direct the Staff of the Commission (Staff) to review the application and file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Public Policy and Outreach Department shall make notice of this order available to the news media serving the residents of the City of St. Louis, Missouri and to the news media serving the residents of the 98 Missouri counties listed in Paragraph 35 of the application.
2. Any person or entity wishing to intervene in this matter shall file an application to intervene no later than February 11, 2026.
3. Staff shall file a recommendation regarding the application, or a status report stating when it expects to file a recommendation, no later than March 9, 2026.

4. This order is effective when issued.
