## NOTICE RECOGNIZING NAME CHANGE AND RELATED TARIFF SHEETS BECOMING EFFECTIVE

The Commission has reviewed the filings and 20 CSR 4240-28.011(2) and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name change of BPS Telephone Company to BPS Telephone Company d/b/a BPS Fiber.
