## MOTION FOR EXTENSION OF TIME TO FILE TARIFF SHEETS RELATED TO THE M.P.B., INC. ASSETS

COMES NOW Confluence Rivers Utility Operating Company, Inc. ("Confluence Rivers"), and, as its *Motion for Extension of Time to File Tariff Sheets Related to the M.P.B, Inc. Assets*, states as follows to the Missouri Public Service Commission ("Commission"):

- 1. The Commission's *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* ("Commission Order"), among other things, approved Confluence Rivers' acquisition of two sewer systems operated by M.P.B., Inc. Villa Ridge and Lake Virginia. (Stipulation and Agreement, p. 4)
- 2. On April 19, 2019, Confluence Rivers closed on the Villa Ridge system assets. However, Confluence Rivers has not yet closed on the Lake Virginia system because of a pending easement issue.
- 3. The Commission's Order also required Confluence Rivers to "file adoption notice tariff sheets for each tariff currently in effect for the regulated Selling Companies, as 30-day filings, within ten (10) days of closing on the respective assets." (Commission Order, p. 11)
- 4. Because of the uncertainty with the Lake Virginia system closing, it not clear what direction is most appropriate in regard to the Villa Ridge tariff filing. Accordingly,

Confluence Rivers hereby requests a two week extension, or until May 13, 2019, for the filing of tariff sheets associated with the Villa Ridge assets. Such extension will provide the Company additional time to determine the most efficiency way to move forward with this tariff filing.

WHEREFORE, Confluence Rivers requests a Commission order consistent with the motion described above.
