**NOTICE OF TARIFF SUBSTITUTION AND  
MOTION FOR EXPEDITED TREATMENT**

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and under 20 CSR 4240-4.017(1), and for its notice that is filing a substitute tariff and for its Motion for Expedited Treatment, states as follows:

1. On December 1, 2025, Ameren Missouri filed a tariff sheet and supporting testimony to adjust the rate of its Missouri Energy Efficiency Investment Act (MEEIA), Energy Efficiency Investment Charge (EEIC).

2. On January 9, 2026, the Missouri Public Service Commission (MPSC) issued an order approving the tariff, to be effective February 1, 2026.

3. Earlier this week, Ameren Missouri discovered an error in the tariff rate tables in the filed EEIC tariff. This is the only error, the Summary EEIR components and the Total EEIR numbers do not change. The Company has notified Staff of this error.

4. Ameren Missouri filed a substitute tariff yesterday but inadvertently failed to file this motion. The Company asks the Commission to approve the substitute tariff so that it can go into effect on February 1, 2026, the same date the previous approved tariff was to become effective. Ameren Missouri has already programmed its systems with this new rate. Ameren Missouri has filed this substitute tariff and motion as soon as practicable after discovery of the error and approval

of this substitute tariff will not cause a disadvantage to Ameren Missouri's customers or to any party in this case.

WHEREFORE, Ameren Missouri asks the Missouri Public Service Commission to approve the substitute tariff so that it can take effect on February 1, 2026, and for any further action as deemed appropriate.
