ORDER APPROVING SUBSTITUTE TARIFF SHEET

Issue Date: January 23, 2026

Effective Date: February 1, 2026

On December 1, 2025, Union Electric Company d/b/a Ameren Missouri filed a tariff sheet, with supporting testimony, to adjust the rate of its Missouri Energy Efficiency Investment Act (MEEIA) Energy Efficiency Investment Charge (EEIC). The tariff sheet bore an effective date of February 1, 2026, and has been assigned Tracking No. JE-2026-0075.

On January 9, 2026, the Commission approved the tariff sheet in its *Order Approving Rider Energy Efficiency Investment Charge Tariff Sheet*.

On January 21, 2026, Ameren Missouri filed a substitute tariff sheet to correct a figure.

At the direction of the Commission, the Staff of the Commission (Staff) reviewed the substitute tariff sheet and, on January 22, 2026, recommended the Commission approve the tariff sheet. No other responses were filed.

Based on Staff's recommendation, the Commission will approve the tariff sheet. To enable the tariff sheet to become effective on the date requested by Ameren Missouri, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The substitute tariff sheet, filed on January 21, 2026, and assigned Tracking No. JE-2026-0075, is approved to become effective on February 1, 2026:
