NOTICE OF UPCOMING WORKSHOP AND TECHNICAL SESSIONS

The Commission established this case to develop new integrated resource planning (IRP) rules for electrical corporations pursuant to Section 393.1900, RSMo. The Commission will hold a workshop and three technical sessions so interested stakeholders may assist in the development of new IRP rules. The workshop will be held in-person on April 16, 2026.¹ The three technical sessions will be held virtually on April 21, 23, and 30.² All interested stakeholders are invited to participate in the workshop and technical sessions.

Therefore, the Commission is providing notice of the upcoming IRP workshop and technical sessions. Prior to the April 16, 2026, workshop, the Commission will issue an order setting the workshop, technical sessions, and providing the necessary information to attend.
