On October 16, 2025, the Commission ordered the Staff of the Commission (Staff) to file a pleading indicating when it can file a recommendation by January 22, 2026. On January 22, 2026, Staff filed its *Status Report* stating that due to the scale and complexity of the acquisition, additional time will be necessary and requested an extension of one week to January 29, 2026, in order to complete its recommendation.

The Commission finds this request reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. Staff's request for an extension is granted.
2. No later than January 29, 2026, Staff shall file a recommendation or alternative pleading regarding Missouri-American's application.

3. This order shall be effective when issued.
