ORDER SUSPENDING THE PROCEDURAL SCHEDULE, CANCELING THE EVIDENTIARY HEARING, AND DIRECTING FILING

On January 26, 2026, Union Electric Company d/b/a Ameren Missouri filed a motion to suspend the procedural schedule on behalf of the parties. The motion states that some of the parties have reached an agreement resolving all disputed issues in this case. Ameren Missouri represents that the other parties have indicated that they will join or not oppose an agreement. The motion requests that the Commission suspend the procedural schedule pending the filing of a stipulation and agreement.

The Commission will grant the motion to suspend the procedural schedule, cancel the currently set evidentiary hearing and order a deadline for any agreement or a status report.

THE COMMISSION ORDERS THAT:

1. The procedural schedule is suspended.
2. The evidentiary hearing scheduled for February 2-6, 2026, is canceled.
3. The parties shall file a copy of any agreement reached or a status report on this matter no later than February 6, 2026.

4. This order is effective when issued.
