**ORDER GRANTING MOTION FOR EXPEDITED TREATMENT AND APPROVING TARIFF SHEETS**

Issue Date: March 31, 2021

Effective Date: April 9, 2021

On February 24, 2021,<sup>1</sup> the Commission issued its Order Granting Certificate of Convenience and Necessity (Order). The Order granted Missouri-American Water Company (MAWC) a certificate of convenience and necessity (CCN) to install, own, acquire, construct, operate, control, manage, and maintain a sewer system in the City of Trimble, Missouri, and in a residential development called Centennial Acres located near Trimble, Missouri.

The Order required that the Centennial Acres customers be charged MAWC's currently effective flat rate of \$38.75 per month for a single-family resident established in MO PSC No. 26, Sheet No. RT 3.1. The order approved MAWC's adoption of sewer rates pursuant to MAWC's current sewer tariff MO PSC No. 26 for both the City of Trimble and Centennial Acres. The order required that MAWC submit newly created

and/or revised tariff sheets, to become effective before closing on the assets. The tariff sheets include:

- i. Index (Sheet No. IN 1.1)
- ii. Index (Sheet No. IN 1.3)
- iii. Index (Sheet No. IN 1.4)
- iv. Index (Sheet No. IN 1.5)
- v. Rules (Sheet No. 13.4)
- vi. Sewer rates (Sheet No. RT 3.1)
- vii. Sewer charges (Sheet No. SC 1.1)
- viii. Service area map (Sheet No. MP 18.1)
- ix. Service area written description (Sheet No. CA 17.1)

On March 24, MAWC filed Tariff Revision (JS-2021-0173) and a Motion for Expedited Treatment. The proposed tariff sheets bear a date of issue of March 24 and an effective date of April 23. The Motion for Expedited Treatment asked for the Commission's order allowing the proposed tariff sheets to go into effect on April 9 because the City of Trimble and Centennial Acres were prepared to close on those transactions on that date. On March 25, the Commission issued its order directing the Commission's Staff to file its recommendation no later than March 29 and setting that date as a deadline for any objection or responses to the tariff sheets. On March 25, MAWC filed Substitute Tariff (JS-2021-0173).

On March 29, Staff filed its recommendation recommending approval of the tariffs. The Commission received no other objections or responses to the tariffs. The Commission has authority to approve the tariff sheets pursuant to Sections 393.140(11) and 393.150, RSMo, 2016. The Commission has reviewed the tariff sheets and Staff's recommendation. The Commission finds that the tariff sheets are consistent with the Commission's February 24 order and should be approved. The Commission finds good cause to grant MAWC's Motion for Expedited Treatment in order that the tariff sheets may


go into effect on April 9 when closing on the assets occurs and prior to their current April 23 effective date. The Commission will grant MAWC Motion for Expedited Treatment and order that the tariffs shall be effective on April 9. In order that the effective date of this order will conform to the effective date of the tariffs, the Commission will make this order effective on April 9.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets, JS-2021-0173, filed on March 24, 2021, as substituted on March 25, 2021, are approved to be effective on April 9, 2021.
2. MAWC's Motion for Expedited Treatment is granted.
3. This order shall be effective on April 9, 2021.
