## NOTICE OF DEFICIENCY

Issue Date: April 5, 2021

On March 26, 2021, Southwestern Bell Telephone Company d/b/a AT&T Missouri (AT&T Missouri) filed an application for approval of an amendment to an interconnection agreement with Big River Telephone Company, LLC. Commission Rule 20 CSR 4240-4.017 requires that an applicant file a notice at least 60 days before filing their application. That requirement can be waived by the Commission. A request for waiver can be accomplished by following instructions on the Commission's website that require that applications for approval of an amendment to an interconnection agreement contain a statement that:

by signing this form, I hereby certify that neither I, nor any other members of this filing party, has had communications with a Commissioner, Commissioner Advisor, Regulatory Law Judge, member of the General Counsel or any member of their support team in the sixty (60) days prior to the filing date of this application regarding any substantive issue included in this filing. If any communication of this sort has occurred in the previous sixty (60) day period, I further certify this application was held until sixty (60) days have passed from the date of the subject communication, or we have requested a waiver for good cause as allowed by Commission Rule 20 CSR 4240-4.017(1)(D).

The Commission will not take action on AT&T Missouri's request for approval of the interconnection agreement until this deficiency is corrected.
