## CORRECTED ORDER SETTING LOCAL PUBLIC HEARINGS

This order corrects the earlier issued Order Setting Local Public Hearings by adding the telephone number to call for participation in the virtual public hearing.

On December 15, 2025, Timber Creek Sewer Company (Timber Creek) filed a Staff assisted rate increase request. It is now necessary to hold public hearings and the parties have agreed to hold two hearings; one live and one virtual. No party has objected. Scheduling for the hearings cannot be made within 60 days so that requirement will be waived. Thus, the Commission will order local public hearings and a corresponding notice.

### THE COMMISSION ORDERS THAT:

1. The Commission's Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of each local public hearing. Comments to the Commission from the public will begin at the conclusion of the question and answer session.

2. Timber Creek, the Staff of the Missouri Public Service Commission (Staff), and the Office of the Public Counsel shall make a representative available to address substantive issues during the question-and-answer sessions. Any other party may also choose to have a representative present.

3. No later than ten days before the local public hearings, Timber Creek shall provide notice of the hearings to each of its customers. Such notice shall use the following language:

Timber Creek Sewer Company (Timber Creek) filed a Staff assisted rate increase request with the Missouri Public Service Commission (“PSC”). The requested increase would total approximately \$890,000 for operating revenue.

### **Local Public Hearing Information**

The PSC is holding public hearings where customers can ask questions and testify about Evergy’s rate request. Customers are encouraged to participate in the hearings.

Each hearing is divided into two parts. In the first part, you may ask questions of Timber Creek, the Missouri Office of the Public Counsel (“OPC”), and the PSC Staff. The PSC Commissioners and the regulatory law judge will not attend the informal question and answer session. Your questions and the answers provided will not be part of the evidence the PSC reviews. In the second part, PSC Commissioners and a regulatory law judge will be present, and you may testify as part of the official record of the case.

Public hearings will be held in person and virtually according to the following schedule:

4. So that everyone has a chance to speak, comments at the hearings will be limited to five minutes per person.

5. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the media and the General Assembly representing customers in Timber Creek Sewer Company service areas.

6. The Commission's Data Center shall provide a copy of this order to the county commission for each county in the Timber Creek Sewer Company service area.

7. For good cause, the 60-day hearing requirement shall be waived.

8. This order shall be effective when issued.
