Statewide

The Commission has reviewed the application filed by the Company and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing within 60 days before filing the application. 1. MCC Network Services, LLC is granted certification to provide Basic Local, Non-Switched Local Telecommunications Services, and Interexchange Telecommunications Service in the exchanges set forth in the affidavit attached to the application and restated above.
2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
3. This order shall become effective on April 18, 2021.
4. This file may be closed on April 19, 2021.
