AMENDED STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Status Report* in this matter states as follows:

1. On June 30, 2021, Evergy Metro, Inc. d/b/a Evergy Missouri Metro, and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri Metro” or “Evergy Missouri West”, or collectively “Evergy”), filed an *Application of Evergy Missouri Metro and Evergy Missouri West for Accounting Authority Order Related to Winter Storm Uri and Costs and Financial Impacts*, requesting an accounting authority order related to Winter Storm Uri.

2. On July 22, 2021, the Commission ordered Staff to file its recommendation in the above-captioned matter by September 23, 2021.

3. The *Staff Recommendation* was filed on September 23, 2021, followed by Evergy’s Response, filed on October 7, 2021.

4. On March 22, 2022, the Commission entered an *Order*, directing the parties to submit a proposed procedural schedule by April 15, 2022.

5. After granting the Staff’s *Motion to Suspend Filing of Proposed Procedural Schedule*, filed on April 12, 2022, the Commission entered an *Order* on April 13, 2022, suspending the procedural schedule.

6. The issues surrounding the requested Accounting Authority Order remain but do not need to be resolved by the Commission due to the Commission's order approving Evergy Missouri West's securitization petition, File No. EF-2022-0155, which was appealed to the Missouri Court of Appeals, Western District, by the Office of the Public Counsel on November 17, 2022, and is now pending oral argument in September 2023.¹ Until that appeal is final, this docket should continue to be held in abeyance.

7. Counsel for Evergy, Midwest Energy Consumers Group, and the Office of the Public Counsel have been contacted regarding this filing. Counsel for Evergy and Midwest Energy Consumers Group have indicated their client's concurrence with this filing. Counsel for the Office of the Public Counsel states that the Office of the Public Counsel does not concur in Staff's recommendation, but does not oppose the Commission leaving this case open, but taking no action in it.

WHEREFORE, Staff files this *Status Report* for the Commission's information and knowledge.
