ORDER DIRECTING A STAFF TARIFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On January 29, 2026, The Empire District Electric Company d/b/a Liberty filed a tariff sheet, Tracking No. JE-2026-0098, to update the Renewable Energy Purchase Program rate. Liberty's tariff sheet bears an effective date of April 1, 2026. The Commission will direct its Staff to examine the tariff sheet and file a recommendation as to whether it should be approved. The Commission will also set a deadline for any other comments about Liberty's tariff sheet.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation about Liberty's tariff sheet no later than March 7, 2026.
2. Any other comments about Liberty's tariff sheet must be filed no later than March 7, 2026.
3. This order is effective when issued.
