On February 11, 2025, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively, Evergy) filed a Motion to Open a New Docket Dedicated to Reviewing Consolidation of Jurisdictions. Evergy did so due to a stipulation the Commission approved in Evergy's prior rate case, Case No. ER-2024-0189.
