ORDER ESTABLISHING ENDING ACA BALANCES

Issue Date: February 5, 2026

Effective Date: March 7, 2026

The Commission opened this case to receive the 2023-2024 Purchased Gas Adjustment (PGA) and Actual Cost Adjustment (ACA) filings of Spire Missouri Inc. d/b/a Spire for its eastern (Spire East) and western (Spire West) operating divisions. The Staff of the Commission (Staff) filed a recommendation and memorandum regarding those ACA filings on December 15, 2025. Staff's recommendation and memorandum indicated Staff had completed a review of billed revenues and actual gas costs for the period of October 1, 2023, through September 30, 2024, that were included in Spire's computation of its ACA balances.

Staff's recommendation and memorandum set out the ending balances contained in Spire's ACA filing and recommended some monetary adjustments to those ending balances. Staff also offered some non-monetary recommendations regarding Spire's policies and practices. Spire responded to Staff's recommendations on January 16, 2026, accepting Staff's analysis and recommendations.

No other responses to Staff's recommendation and memorandum or to Spire's

response were received.

After reviewing Staff's recommendation and Spire's response, the Commission concludes that Staff's ending ACA balances should be accepted as a resolution of Spire's 2023-2024 ACA audit.

THE COMMISSION ORDERS THAT:

1. The ending (over)/under recovery balances for Spire's 2023-2024 Actual Cost Adjustment for its two operating divisions are established as provided in the following table:
