ORDER ESTABLISHING ACA BALANCE

Issue Date: February 5, 2026

Effective Date: March 7, 2026

Procedural History

This case was opened to receive the 2023-2024 Actual Cost Adjustment (ACA) filing of Union Electric Company d/b/a Ameren Missouri. On December 10, 2025, the Staff of the Commission (Staff) filed a recommendation.

On January 9, 2026, Ameren Missouri filed its Response to Staff Recommendation. On February 2, 2026, Staff filed *Staff's Reply and Recommendation Approving Union Electric d/b/a Ameren Missouri's 2023-2024 Actual Cost Adjustment Balances*. Staff states that the parties have no disagreement, and that the Commission should approve Ameren Missouri's ACA balances as requested by Staff.

Decision

The Commission has reviewed the pleadings. The Commission determines that the ending balances agreed upon by Staff and Ameren Missouri are reasonable and should be approved. The below Staff-recommended ACA balances are ordered.
