**STAFF RECOMMENDATION TO APPROVE TARIFF**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and for its recommendation that the Commission approve the tariff sheets filed by Confluence Rivers Utility Operating Company, Inc. ("Confluence Rivers") states the following:

1. On December 17, 2025, the Commission issued its *Order Authorizing Water Systems Acquisition and Granting Certificate of Convenience and Necessity*. The Order directed Confluence Rivers to file compliance tariff sheets.
2. On January 27, 2026, Confluence Rivers filed tariff sheets, Tracking No. JW-2026-0097, bearing an effective date of February 26, 2026.
3. On January 27, 2026, the Commission issued its *Order Directing Recommendation on Compliance Tariff Sheets*. The Order directed Staff to file a recommendation regarding whether the tariff sheets comply with the Commission's December 17, 2025 Order no later than February 10, 2026.
4. Staff has reviewed the tariff sheet submitted by Confluence Rivers and recommends its approval.

**WHEREFORE**, Staff respectfully submits this Staff Recommendation to Approve Tariff, and respectfully requests the Commission approve the tariffs filed by Confluence Rivers.




