On January 27, 2026, the Commission issued its *Order Directing Recommendation on Compliance Tariff Sheets* in which it directed its Staff to file a recommendation regarding the tariff sheets filed earlier on the same date by Confluence Rivers Utility Operating Company, Inc.

On February 10, 2026, Staff filed a recommendation that the Commission approve the tariff sheets. The Commission will shorten the time for parties to respond to Staff's recommendation.<sup>1</sup>

1. Any responses to Staff's recommendation shall be filed no later than February 11, 2026.
