On January 29, 2026,<sup>1</sup> Staff filed *Staff Report and Recommendation* (Report). The Report stated that Staff recommended approving the Certificate of Convenience and Necessity, subject to 17 conditions.

On February 9, Missouri-American responded, objecting to the second, seventh and eighth conditions, but not objecting to the others.

Accordingly, the Commission will direct Staff to respond.
