NOTICE OF FILING FUEL SUPPLY PLAN

COMES NOW, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“EMW”) and, pursuant to the Missouri Public Service Commission’s (“Commission”) *Report and Order* (“Report and Order”) issued in Docket No. EA-2025-0075 on July 31, 2025, states as follows:

1. Paragraph 90 of the *Report and Order* states:

90. A condition stated in the Agreement is that Evergy Missouri West agrees to collaborate with Staff and OPC during the development of a Gas Purchasing Plan, and to file the results of the plan as a compliance filing in this docket. The filing of such a plan, along with any collaborative meetings would not imply pre-approval or prudence review acquiescence regarding the initial plan or any updates or changes. Thereafter, until the time the Projects are placed in service, Evergy Missouri West agrees to meet annually with Staff, MECG, and OPC to discuss potential revisions to the Gas Purchasing Plan.¹

2. Pursuant to the *Report and Order*, please find EMW’s **CONFIDENTIAL** Fuel Supply Plan attached hereto as **CONFIDENTIAL Exhibit A**.

3. Additionally, collaborative meetings were held with Staff (“Staff”) for the Commission and the Office of the Public Counsel (“OPC”) on the following dates with the topic(s) covered as indicated:

September 24, 2025: Natural Gas Procurement and Transportation
September 25, 2025: Natural Gas Procurement and Transportation
October 8, 2025: Natural Gas Procurement and Transportation
December 22, 2025: Initial Fuel Supply Plan
