ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: February 13, 2026

Effective Date: February 26, 2026

On December 17, 2025, the Commission issued its *Order Authorizing Water Systems Acquisition and Granting Certificate of Convenience and Necessity* in this matter. Among other things, that order directed Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) to submit tariff sheets, to become effective before closing on the acquired assets, to account for the acquired service area in its tariff.

On January 27, 2026, Confluence Rivers filed tariff sheets purporting to be in compliance with the terms of the Commission's December 17th order. The new tariff sheets have been assigned Tracking No. JW-2026-0097 and each bear an effective date of February 26, 2026.

On February 10, 2026, the Staff of the Commission (Staff) filed its recommendation that the proposed tariff sheets be approved. No responses to Staff's recommendation were filed by the deadline set by the Commission.

Upon reviewing the pleadings and Staff's recommendation, the Commission finds Confluence Rivers' proposed tariff sheets comply with the Commission's December 19th

order and will approve them. So that the tariffs can become effective on February 26, 2026, the Commission finds it reasonable for this order to be effective in less than 30 days.
